FCA has a Code of Conduct that lays down standards of relationships of employees of FCA with stakeholders including its consultants, bidders, suppliers and customers. The Code mandates ethical, fair and transparent dealings by FCA, its employees and other stakeholders with outsiders making fair and ethical business practices the backbone of FCA's dealings with outsiders. Outsiders dealing with FCA in general and its employees and stakeholders in particular are expected to abide by the highest standards of conduct and ethical behavior and are obliged to report all non-conformities.
